CORRIGENDUM TO NOTICE OF EXTRA-ORDINARY GENERAL MEETING ("EGM")

Dear Shareholders,

This Corrigendum ("Corrigendum") is being issued in continuation to and should be read in conjunction with the Notice of Extra-Ordinary General Meeting ("EGM") dated January 09, 2026 ("Original Notice") circulated to the Members of the Company in respect of the proposed issue of convertible Warrant(s) on preferential basis pursuant to Sections 42 and 62 of the Companies Act, 2013 read with applicable rules and Chapter V of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("SEBI ICDR Regulations").

An Extra-Ordinary General Meeting ("EGM") of the Shareholders of the Company was scheduled and held on Saturday, January 31, 2026 at 11.30 A.M. (IST) through physical mode at its corporate office situated at Plot No-A-29, Pallaspalli, Near Airport, Bhubaneswar-751020, Odisha, India in physical mode.

In the said meeting, the Company has provided facility to its Members to exercise their right to vote by electronic means, through remote e-Voting services as well as e-Voting during the EGM in terms of Section 108 of the Companies Act, 2013, read with the Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended and Regulation 44 of the Listing Regulations. The remote e-voting period commenced on Wednesday, 28 January, 2026 at 9:00 am (IST) and ended on Friday, 30 January, 2026 at 5:00 pm (IST). The business as stated in the original EGM Notice was transacted and got shareholders' approval with requisite majority. The voting result along with detailed Scrutinizer's report in this regard was also disseminated to the Bombay Stock Exchange (BSE) and also uploaded on the website of the company within specified time limit.

However, this corrigendum is issued pursuant to the observation and directions received from Bombay Stock Exchange Limited (BSE) dated February 11, 2026 on Company's application seeking in-principle approval for issuance of convertible Warrant(s) on preferential basis and to align and comply with SEBI (ICDR) Regulations, 2018. These directions were issued due to ineligibility of one of the proposed allottee "Dhatri Software Solutions Pvt. Ltd." for selling shares of Paradeep Parivahan Limited during the relevant pricing period. In this regard, this Corrigendum to original EGM Notice is hereby notified to all the shareholders of the Company with all consequential revisions in the information/documents of Warrants issue. Hence, this Corrigendum forms an integral part of the original EGM Notice and should be read in conjunction with the original EGM Notice.

As directed by BSE, the Company shall re-open the remote e-voting facility for its shareholders for 48 hours to vote again on the resolution proposed in the Corrigendum to original EGM Notice specifically to ensure compliance with Regulation 163 of the SEBI (ICDR) Regulations, 2018 regarding preferential allotment of Warrants. Details of e-voting facility are given in the later part of this corrigendum.

The following information/amendment in the original EGM Notice is hereby notified through this corrigendum to all the shareholders of the Company:

- The Special Business mentioned in the Original EGM Notice shall be replaced and read as given in this Corrigendum.
- In the explanatory Statement to Item No. 1 "1) The object of the issue" of the Original Notice shall be replaced and read as follows:

a) Objects of the Issue:

The Company proposes to issue, offer and allot up to 10,40,000 (Ten Lakhs Forty Thousand) Convertible Warrants on a preferential basis and to raise an amount aggregating up to Rs. 16,27,18,400/- (Rupees Sixteen Crores Twenty-Seven Lakhs Eighteen Thousand Four Hundred Only). The object of the proposed issuance of Convertible Warrants on a preferential basis is to mobilize funds to support the Company's strategic and operational requirements. The Company intends to utilize the proceeds to be raised through the Preferential Issue ("Issue Proceeds") towards the following objects:-

- General Corporate Purposes: Up to 25% (twenty five percent) of the Issue Proceeds will be utilised for general corporate purposes, which includes, inter alia, meeting ongoing general corporate exigencies and contingencies, expenses of the Company as applicable in such a manner and proportion as may be decided by the Board from time to time, and/or any other general purposes as may be permissible under applicable laws (referred to as "General Corporate Purposes") (collectively referred to as the "Objects").
- Working Capital Requirements: Up to 75% (Seventy-five) of the Issue Proceeds will be utilised for working capital to strengthen the Company's financial position and support day-to-day operational needs.

Gavaskar, Kapil Dev seek fair treatment for jailed Imran Khan

Displaying sporting camaraderie and cross-border solidarity, Indian cricket greats, including Sunil Gavaskar and Kapil Dev, have expressed "deep concern" over jailed cricketer and former Prime Minister Imran Khan's deteriorating health. Along with 12 other former cricket captains, they urged the Pakistan government to provide adequate medical care and dignified conditions in line with international standards.

This appeal came in the backdrop of reports that the 1992 World Cup-winning skipper Imran has lost approximately 85 per cent of vision in his right eye due to medical neglect while in custody at Rawalpindi's Adiala Jail. In 2023, Khan, the former Pakistan prime minister, was sentenced to 14 years in prison in a corruption case. He served as Pakistan's Prime Minister from 2018 to 2022.

As many as 14 former captains wrote a letter titled "Appeal by former International Cricket Captains" to the Pakistan government, asking for fair treatment for Khan.



"We, the undersigned former captains of our national cricket teams, write with deep concern regarding the reported treatment and incarceration conditions of Imran Khan, the distinguished former captain of Pakistan and a legendary figure in world cricket," the letter said. "Recent reports concerning his health — particularly the alarming deterioration of his vision while in custody — and the conditions of his imprisonment over the past two and a half years have caused us profound concern.

"As fellow cricketers who understand the values of fair play, honour, and respect that transcend the boundary rope, we believe that a person of Imran Khan's stature deserves to be treated with the dignity and basic human consideration befitting a former national leader and a global sporting icon." The letter has also been signed by Michael Atherton, Allan Border, Michael Bevan, Greg Chappell, Ian Chappell, Belinda Clark, David Gower, Kim Hughes, Nasser Hussain, Clive Lloyd, Steve Waugh and

John Wright. In the letter, the group of former captains asked for proper medical attention, transparent legal procedures and dignified treatment for the 73-year-old Khan. "We respectfully urge the Government of Pakistan to ensure that Imran Khan receives immediate, adequate and ongoing medical attention from qualified specialists of his choosing to address his reported health issues."

"Humane and dignified conditions of detention in line with international standards, including regular visits by close family members. Fair and transparent access to legal processes without undue delay or hindrance. "Cricket has long been a bridge between nations. Our shared history on the field reminds us that rivalry ends when the stumps are drawn and respect endures. Imran Khan embodied that spirit throughout his career."

The letter called on authorities to uphold the principles of "decency and justice". "This appeal is made in the spirit of sportsmanship and common humanity, without prejudice to any legal proceedings."

The letter highlighted Khan's contributions to cricket and also as a politician. "Imran Khan's contributions to the game are universally admired. As captain, he led Pakistan to their historic 1992 Cricket World Cup victory, a triumph built on skill, resilience, leadership, and sportsmanship that inspired generations across borders."

"Many of us competed against him, shared the field with him, or grew up idolising his all-round brilliance, charisma, and competitive spirit. He remains one of the finest all-rounders and captains the sport has ever seen, earning respect from players, fans, and administrators alike. "Beyond cricket, Imran Khan served as Prime Minister of Pakistan, leading his nation during a challenging period. Regardless of political perspectives, he holds the honour of having been democratically elected to the highest office in his country." Gavaskar spoke about his long-time rival and friend. "It's terrible what they are doing to him. We have been friends since he was trying to qualify as an overseas player for Worcestershire and not just rivals on the field."



Time for Dewald Brevis to show his prowess

South Africa would expect big-hitting youngster Dewald Brevis to regain his form against a struggling United Arab Emirates in their inconsequential final Group D fixture of the T20 World Cup here on Wednesday.

South Africa are already through to the Super Eights with three wins, including a double Super Over cliffhanger against Afghanistan and a comprehensive seven-wicket thumping of New Zealand. For the UAE, it will be an opportunity to test their skills against the likes of Marco Jansen, Kagiso Rabada and Lungi Ngidi, a bowling attack which they don't get to face often at the international level as most of the Proteas players ply their trade in SA20, which clashes with their ILT20.

For South Africa, the match against UAE will be an extended practice game in which they would look to bat first and make full use of a placid track on offer at the Feroz Shah Kotla ground.

In the top four, Quinton de Kock, Aiden Markram and Ryan Rickleton have all got at least one half-century in the three games so far but Brevis, with scores of 6, 23 and 21, hasn't exactly displayed his full potential. Known as 'Baby

AB' for batting similarities with the great AB de Villiers, Brevis' propensity to play irresponsible shots in between flashes of brilliance has proved to be a hindrance in taking the leap to the next level.

It is precisely for this reason that the 22-year-old is not yet considered on par with the likes of Shubman Gill, Harry Brook, and Yashasvi Jaiswal to name a few.

Even though the UAE attack doesn't even have bowlers with express pace, the belter at Kotla will give Brevis a chance to return to form before the big Super Eights game against India at Ahmedabad.

As far as changes in the playing eleven are concerned, it is unlikely that the batting set-up will be tinkered with but Markram might just want to rest his main fast bowlers Rabada and Ngidi, giving a chance to Anrich Nortje and teenager Kwena Maphaka.

For UAE, the onus of scoring runs will be on former Jamia Milia Islamia student Sohaib Khan, who has already scored successive fifties in the tournament and has been their batting mainstay.

Skipper Muhammad Waseem and Alishan Sharafu are the other two batters on whom the Lalchand Rajput-coached side will like to depend for run-scoring.

Canada's Yuvraj becomes youngest to hit century in T20 World Cup

Canada's Indian-origin batter Yuvraj Samra became the youngest to score a hundred in the T20 World Cup's history when the 19-year-old smashed a career-best 65-ball 110 against New Zealand in a Group D match here on Tuesday. The youngster, who was named after Indian swashbuckler Yuvraj Singh by his cricket fan father Baljit Samra, was playing in only his 19th T20 International since making his debut in March last year.

Samra struck 11 fours and half a dozen sixes during his whirlwind knock, which became the foundation of his team's 173-run total against the higher-ranked opponents.

He was dismissed in the final over while attempting another big hit against Jacob Duffy.

His innings is also the highest individual score for an Associate team's batter in the



biennial showpiece. The record for the fastest hundred in the T20 World Cup was previously held by Pakistan's Ahmed Shehzad, who was 22-year-old when he touched the milestone in 2014.

India likely to steamroll Netherlands, but Dutch are not intimidated

A red-hot India is expected to steamroll the Netherlands in their final T20 World Cup league fixture on Wednesday but the Dutch are not intimidated by that prospect. They are instead psyched about playing at the world's largest cricket stadium, with a capacity of 1.32 lakh, which even at half full would have more people in attendance than the Dutch fans who show up to support their more popular and infinitely more successful football team.

"Playing India in India at the world's largest stadium, it is massive for us. More people would be attending tomorrow's game than the Dutch fans who turn up for their team in a FIFA World Cup," John van Vliet, who handles media and marketing for the Netherlands team, told PTI. "The sponsors back



home should see the value in that, but so far they have not," Vliet said on the eve of the game. The stadium's seats are orange, the colour of Netherlands' sports teams, which are popularly called 'Oranje'.

The story of Netherlands mirrors majority of the semi-professional associate teams taking part in the 20-nation T20 World Cup in India and Sri Lanka. (PTI) It was three days before their tournament-opener that the Netherlands were able to rope in a sponsor. Expectedly it was an Indian sponsor that came

to their rescue, just like it was the case in the 2023 ODI World Cup, which was also staged in the biggest cricketing nation. Financial service firm Globe came on board just three days before the tournament began but Vliet is hoping their association lasts longer than the duration of the tournament. The Netherlands have been a regular in ICC events but the sport still remains on the margins in a football-mad nation. The team has had Dutch companies sponsoring them briefly but they too had an Indian connection. (PTI)
